## rom the Master John Mansfield

Those who attended Common Hall last year will already be aware that I regard myself as a Viking because my mother's family came from Denmark. The Guild of Firefighters was formed in 1988 and was recognised by the City on 13th June 1988. The first Court meeting took place on 15th June 1988 at 140 Aldersgate Street EC1, formerly the Headquarters of the London Salvage Corps. On the 13th June 1995 the Guild fulfilled the first stage of its journey and was granted the status of a City Company without

became known as the Worshipful Company of Firefighters. Finally, our Royal Charter was granted on 11th December 2013.

## **Memorial Day Service** At the National Arboretum in Staffordshire





Worshipful Company The **Firefighters** (WCoFFCT), Charitable Trust continues to consider applications for Grants from worthy causes and support several Fire and Rescue related initiatives along with The Lord Mayor's Charity.

Charitable world is a continually changing environment with the biggest challenge for the Trustees being able to prioritise those applications which will provide the maximum benefit for the recipients against the resources available. The Trustees have considered carefully where priorities should lay for the foreseeable future. Therefore, the Trustee Board have published the Charitable Trust five priorities as:

- 1. Young People, Leadership, Development and Responsible Citizenship,
- 2. Education Research and Projects,
- 3. Fire and Rescue Heritage,
- 4. National Charities Associated with Fire and Rescue and the Fire Industry, and
- 5. Lord Mayor's, Livery Company and City of London Charities.

Since the last Salamander the Trustees have awarded grants to the following applicants:

- London Cadet Leaders Scheme,
- Essex Fire and Rescue Service (Firebreak) Cadet and Young Persons Outreach Scheme.
- London Fire Brigade Sensory Garden at Brixton Fire Station,
- The Burns Camp (Rehabilitation of Young Persons Burnt in Fire Related Incidents)
- London Fire Brigade Marine Cadets (Uniform Provision),
- London Fire Brigade Personnel and Welfare Scheme (Grenfell Tower Fire Counselling and Welfare Provision),
- The Lord Mayor's Charity (Improving the lives Disadvantaged Young People),
- National Fire Chief's Council -Fire Cadets Games 2018
- Greater Manchester Fire and Rescue Service Museum
- Women in the Fire Service (UK Female Fire Safety Education Specialists in Lebanon)

These Charitable Trust Grants amount to over £55,000 and any member of the Charitable Trust can give more details of the Grant Awards and what they are expected to achieve should Members have an Company interest. The WCoFF are fully recognised in each grant and I am delighted to report that we are regularly updated on each project and have invitations by the respective organisations to various events to witness at first hand the work being undertaken. appropriate a Trustee is appointed as liaison for each organisation and monitors the progress in meeting the objectives stated in their grant applications.

The Charitable Trust has made progress on engaging with recognised Educational Establishments over recognition for outstanding Fire and Industry Related Projects and Degrees involving several Universities and Higher Educational Colleges thanks to the work of Liveryman Dr David Crowther and during the forthcoming months we shall be evaluating how this engagement has progressed.

Concern about future Charitable income exists amongst all the Trustees as time progresses. The Charitable Ball which has been a cornerstone of the Charitable Income almost since the formation of the Company just achieved a "break-even" point last year thanks to the organisers and the Fire Industry who sponsored the event. The Charitable Ball has for some vears seen a decline in Company Members attending and sadly is not part of the Company's Annual Calendar of events this year. The Trustee Board continue to be very grateful to the XL Catlin for their Sponsorship of the annual City Dinner in early November that provides substantial income for the Charitable Trust. The Board of Trustees will be shortly considering a range of fund raising options that will be required to sustain our ability to make Grant Awards in the future if we are to continue the valuable work of the Trust.

The Vice-Chairman, Graham Maltby has recently completed comprehensive review our administration and Grant Application process which now wholly electronic and via the Company Website reducing the administration required by our busy Clerk. Senior Past Master Jeremy Beech and the Clerk continue to lead on the process to secure Charitable Incorporation through the process governed by the Charitable Commission.

In the final paragraph on behalf of all the Trustees our sincere thanks to Past Master Michael Harper who has stood down as a Trustee after many years and welcome Maurice Heaster to the Board of Trustees.

## Visit to London Heathrow

## **Heathrow Airport Fire and Rescue Service**



his Deputy, Mark Summerhill, were our hosts for the visit.

In the Compass Centre we had a tour of the multi-agency control centre housing teams responsible for fire, police, medical and border control personnel. As well as the banks of screens covering the buildings and apron areas (mind what you do as you pass through the airport, you are on camera), we were able to look out over the northern runway to look directly at the airport operations. It was a spectacular vantage point, but the view was attenuated by the atrocious weather.

After seeing this part of the complex operation of running a major airport we were taken through security and onto the Central Fire

Station. Here, Gary gave us a very informative presentation on the fire and rescue services on site and the systems in place to collaborate with neighbouring county brigades when the need arises. As a Category 10 airport, with over 450,000 air transport movements and 78 million passengers per year, the Airport Fire Service has some impressive kit, divided between the Central Fire Station and another at the eastern end of the airport. Each station has two Rosenbauer Panther foam tenders, carrying 11,500 litres of water and 1,400 litres of foam. They carry bumpermounted monitors and either a roof monitor or a high-reach extendable turret. In addition, we saw a range of special appliances which included a hose layer, 42m ALP and an extending staircase the Rosenbauer Skystair.

We had yet another treat in store - a visit up the 87m control tower, where we got a 360 degree panoramic view of the airport and a unique view of the Central Fire Station.

Our sincere thanks to Gary and Mark for their splendid hospitality, and also to Liveryman Simon Petts, Gatwick Airport, helped to arrange the visit.

## **Waterloo Station Visit**

## Behind the scenes unique visit to Waterloo Station

A small group of Firefighters had a unique tour behind the scenes of the Waterloo Station upgrade recently. Our visit started with a short overview of the project by the Project Manager for Network Rail, Alison Farwell.

Alison noted the work to extend some of the platforms in the main station, which had been completed last year, and went on to describe the rebuilding of the old Waterloo International Terminal, which was to be the subject of our visit.

Then, courtesy of Liveryman Nicole Hoffmann, who is the Principal Fire Engineer for the project, we were able to tour the former Waterloo International site. where the old platforms 20-24 will be brought back into use for suburban services by December 2018.

Nicole was able to show us many of the fire safety and passenger evacuation features being incorporated into the project design. Our walk around the site included all three levels of the terminal: the platform level, the Orchestra Pit level and London Underground level.

For those of us who had used the old Eurostar lines it was a real treat to see some familiar features of the old terminal. This was very much a tour around an active and busy building site so, as the photo shows, we were all provided with full PPE.

After the visit we adjourned for a light lunch, appropriately in the old 1910 Waterloo Road Fire Station, now a restaurant.

## **MASSEY SHAW EDUCATION TRUST**

Fire Cadet Marine Unit cast's off!



Fire Cadet Marine Unit cast's off! The Massey Shaw Education Trust was pleased to host the first session of the newly founded Fire Cadet Marine Unit aboard the fireboat at the beginning of May.

The Marine Unit has been organised with support of several partner organisations, primarily the RNLI, LFB River Service, Massey Shaw (MS) Education Trust and a generous donation from the Worshipful Company's Charitable Trust. The young people participating in the marine activities have to undertake an in-depth selection process and demonstrate that they are willing to commit to new challenges.

Each of the partners will be providing knowledge on water -based skills, based on their own expertise. The MS Education Trust has developed a programme which informs the Cadets about the life

of a "floatie" on the Thames, and how the fireboat was used to fight fires and save lives during her thirty-six years of service. One of the highlights for the Cadets during our session with them was to start their rowing programme, helped by members of the Docklands Scout Project. Why you might ask would fireboat crew need to be able to row? Well in the early days when the Insurance Companies started to provide a fledgling fire service, fireboats were rowed to incidents by Watermen and Lightermen and Firemen. The floaties as they were called, rowed the floating barges and their Manual Pumps to fires and then rowed the hoses ashore to provide land-based crew with water. This practice continued for many years, even when the fireboats had their own mechanical propulsion and would have been an integral part of Massey Shaw's firefighting capability.

In more recent times, fireboat crews showed their prowess by participating in The Fishmongers Cup Competition, rowing against crews from the Port of London Authority (PLA) and River Police. Unfortunately, this Competition is no longer undertaken, but we hope that the Fire Cadets can show their skills by participating in the annual Great River(GR) Race which takes place each September. The GR Race started in 1988, and last year over 300 rowing craft took part in the 21.6 mile course from Millwall Dock (London Docklands) to Ham in Surrey. We hope that the Marine Fire Cadets will be able to take part in next year's race and provide an opportunity to raise funds for the Worshipful Company's Charitable Trust.

David Rogers CEO Massey Shaw Education Trust Gerry and the Peacemakers of 1918 - 2018



Founder Master Gerry Clarkson, in his other role as Leader of Kent's Ashford Borough Council, engaged with the City of London Corporation and The US National WWI Museum and Memorial to commemorate the centenary of the end of the First World War with an open air photographic exhibition in Guildhall Yard during May.

The exhibition "Fields of Battle, Lands of Peace: 1918 – 2018", highlighted the global nature of the conflict. The exhibition subsequently came to the Memorial Gardens in Ashford throughout June. There integrated with complementary floral displays it was a masterpiece. The use of sandbags reflected the sombre battletorn mood of 1914-18 amidst the green and colourful garden setting. The displays featured a silhouette sentinel by a symbolic grave of a fallen soldier and a decorated miniature replica of a tank, echoing the real one which has pride of place in the town. The real one was presented at the end of WWI in recognition of the town's contribution to the 'National War Savings Appeal'. Congratulations Gerry to you and your fellow sponsors! ## **Kent Firefighting Museum**



**During 2012 Past Masters Jeremy** Beech, Alan Wells and Liveryman Howard Mvers. with others. negotiated with the Kent Fire and Rescue Service to ensure Kent's firefighting heritage was preserved. A charitable trust was formed and fortuitously we were offered some buildings at Woodlands Garden Centre at Ash near Brands Hatch.

The museum was formally opened by Baroness Blackstone in August 2014. Woodlands is a family run venture, by Kim and Wayne Barr. Kim's father, Harry Knox was a former firefighter. The garden centre partnership works well and is very successful. Since

opening more than 26,000 people have visited the museum and donated a little over £15,000. Presentations and displays of artefacts are given to outside organisations and clubs and many groups visit the museum. The museum is well represented on Facebook and Trip Advisor and open seven days a week from 10.00 a.m. to 4.00 p.m. with a brief winter closure period from mid December until the following March. ## Fire Authority to seek judicial review

Cambridgeshire and Peterborough Fire Authority met on Thursday (May 24) and agreed to issue a claim for a judicial review to challenge the Home Office's decision to transfer governance of the fire service to the police and crime commissioner. Members have taken legal advice and believe there has been no evidence presented to demonstrate a business case for the change. Chairman of the Fire Authority, Councillor Kevin Reynolds said: "We have given this careful consideration since the decision was first announced by the Home Office in March. We have requested additional information from the Home Office about the rationale behind the decision and we have sought legal advice. "The fire authority and fire and rescue service work extremely well together under the current governance model and continually

perform well. No reason has been demonstrated as to why a change in governance will bring any substantial benefits. Having taken legal advice, we have decided to challenge the decision by making a claim for a judicial review." The Fire Authority (FA) was formed in 1998 to govern Cambridgeshire Fire and Rescue Service (FRS) when Peterborough became a unitary authority. Prior to that, the county council had been responsible for the county's fire service. Seventeen members 13 from Cambridgeshire County Council and four from Peterborough City Council Fire Authority. make up the Since 1998, with the Fire Authority at the helm, the fire service has continuously been one of the lowest cost fire and rescue services in the country, and scored well in the various assessments

and inspections that have taken place by both government appointed bodies and peers. In more recent vears. Authority has navigated its way two through comprehensive spending reviews where it has needed to find over £7million of savings to meet a reduction in government funding and has done this successfully whilst maintaining frontline services and still improving equipment and vehicles for firefighters. In the last 14 years alone, fires have reduced by 48 per cent and people are safer in their homes with a 44 per cent reduction in accidental fires, a 61 per cent reduction in casualties from fires and a 68 per cent reduction in deliberate fires in our communities.

#### St Neots Fire Station welcomes over 500 children for "Safety Zone"



Cambridgeshire **Fire** and Rescue Service (FRS) held a "Safety Zone" last week at St Neots Fire Station. The five day multi-agency event for local primary schools was attended by approximately 500 school children aged between eight and nine, and gives them vital information on how to keep safe. The children took part in fun activities demonstrations and

provided by Cambridgeshire Fire and Rescue service, Cambridgeshire Constabulary, Cambridgeshire County Council Trading Standards & Road Safety Team and Wood Green the Animals Charity to deliver the important messages to youngsters.

Different agencies set up 'zones' which small groups of children visited to learn about a specific area of safety, including water safety,

home fire safety, the importance of wearing a seat belt, first aid, dangerous toys, how to approach a dog safely and internet safety. Gibbs. Community Safety Officer in St Neots, said: "The Safety Zone is a great way of engaging young people in our community in a fun and interactive way and we're thrilled to host it again this year. This is a great partnership between many services and agencies all working together to make our communities safer places, and feedback from the schools who've attended has been fantastic."

This is the third Safety Zone of the year, and further events will be held later in the year in Peterborough and Ramsey.

## **Working with the Royal Marines**



Devon & Somerset Fire & Rescue Service have been delivering road traffic safety presentations to the Royal **Marines 30 Commando Troop** based in Plymouth for the last three years. This year they demonstrated a Road Traffic Collision (RTC) involved three cars with two fire crews from Plympton fire station attending the exercise.

Plympton's watch manager Neil Willmott explained: "Today is building on the partnership we already have established with 30 Commando Troop with the intention that the relationship will continue to grow. Ву demonstrating how we deal with a RTC we aim to reduce the current trend on the amount of service personnel being involved in road traffic incidents.

"This trend occurs in particular when serving personnel return from deployment and for various reasons while travelling in the UK are being involved in RTCs. The Marines take a lot of risks in their day job and it's important to keep them safe when they are home. That's why we're here. We are really grateful to the 30 Commando for their support. "


Statistics have shown that from 2012 till 2016 there have been 74 deaths across the armed services as a result of RTCs. 95% of these were young males and 39% were involving cars and 35% were involving motorbikes. On top of this is the fact that service personnel are 65% more likely to be involved in these accidents than other member of the general public.

Sergeant Harrison said: Today's event is based on road safety awareness focusing on speeding. This is a massive part of safety for the military especially our department in particular as we are the transport troop. So we use the Lorries; all of the vehicles in fact on a daily basis. So it's raising their general awareness of road safety. "Also the lads drive home every weekend travelling for 6 or 7 hours. So it's that gentle reminder to look after themselves, as we are all human. Today allows the lads to get involved, really hands on, especially with the cutting equipment so they know what it's like to work with. We have been liaising with Neil Willmott for three years and every year is a new presentation with a road safety focus."

Medic MA Spaars said: really enjoyed the day. As medics we never normally work with the fire service like this so we didn't have any idea of what they do at a RTC. I was involved in dealing with the casualties and the Fire Service continued to work around me cutting the car, then everyone helped get them out of the car and carry them to a safe place.

A really good experience. "

#### **London's Fire Engines**




**Volume 1** spans early manuals and horse-drawn appliances to



As we enter this period of change, nationally with Brexit, the change of the Civic Team in the City, and more importantly within the

Company, I feel that it may be a good time to reflect on whether the Company is still; to use Business parlance: Fit for Purpose?, Actively engaging with the membership?, Value for money?, or does it need to change / adapt / evolve?, reengage with its members?, look at how to be better value?, any of the above, some of the above or all of the above.

I cannot give you any answers for the above questions, all I can do as your Clerk is to give pointers, suggestions and advice to those Committees and Individuals that will have to make them.

What I can say without sounding like our Honourable Treasurer or Chairman of the Finance Committee is that the Company has at present, approximately 200 members, however our Formal and Civic events can only see approximately a 2 - 20% take up, for a good example - look around you today, this event is arguably the most important in the Company's annual calendar, yet there are only approximately 30 members here, with another 40 giving apologies. A total of 35% replies and a take-up of 15%.

I know that in this room today, I am "preaching to the converted", but this report is also being published in the next edition of the Salamander and therefore to all members of the company, and it is to the wider audience that I am really speaking to.

But seriously, the Company needs to..., NO MUST, find a way of reengaging with our membership so that all our events, not just the Formal and Civic events are oversubscribed all the time!

Equally, the Charitable Trust need to ensure that members remember one of their first agreements with the Company, that of charitable giving. To put it bluntly, without your donations into the Trust, the Trustees will not be able to

discharge their duty on behalf of the Company and assist those in greater need and less able than ourselves, and again attendance at the Company's Charitable events are to say the least disappointing, as is the percentage of members regularly donating.

Again, to use business terminology, where is the Company's 5 or 10 -year strategy plan, does it need one? Where do we see the Company at the end of that period?

Would this be a good time to look into a small but efficient working group to give the Company a Root and Branch review and set up a strategy and policy that Court could approve and which would enable us to go forward, whilst keeping in touch with the original Aims and Objectives of the Company.

As many, if not all of you are aware, the Company has had to change, we are holding what will most probably be our last Common Hall in the magnificent surrounding of the Great Hall of Insurance Hall.

As from 2019 we shall most probably be holding most of our Company events in our new home of the Wax Chandlers' Hall, or elsewhere.

The Office after many years has had to leave Insurance Hall and is almost back up to speed and hopefully giving the membership a good service. If not please let us know, it is the only way that we can try to improve our service to you all.


